NOTICE OF HEARING

TAKE NOTICE THAT the Professional Conduct Committee of the Saskatchewan Association of Medical Radiation Technologists (SAMRT) has issued a report to the Discipline Committee recommending that the Discipline Committee conduct a hearing into the complaints against you as follows:

That you, Anthony Fernandes, are guilty of professional misconduct, pursuant to section 23 of *The Medical Radiation Technologists Act, 2006* in that, on or about May 30, 2015, you altered a letter you had received from the Canadian Association of Medical Radiation Technologists that stated you had successfully completed a CT imaging 1 course so it would say that you had completed the CT imaging 2 course, when you had not in fact completed that course, in order to be qualified for a position with the Saskatoon Regional Health Authority, and your actions in so doing:

(a) are harmful to the best interests of the public or the members contrary to clause 24(a) of *The Medical Radiation Technologists Act, 2006*;

(b) tend to harm the standing of the profession contrary to clause 24(b) of *The Medical Radiation Technologists Act, 2006*; and/or

(c) are a breach of section 19 of *The Medical Radiation Technologists Regulatory Bylaws, 2015*, which requires compliance with the *Code of Professional Conduct* contained in Schedule B, in that you thereby failed to conduct himself in a manner that maintains public trust and respect in accordance with clause 1(c) of the Code.

AND TAKE NOTICE THAT under the provisions of the Act, you are entitled to be personally present and to be represented by legal counsel or agent.

AND TAKE NOTICE THAT if you do not attend the hearing, the Discipline Committee may proceed in your absence.

You are entitled to disclosure of the evidence against you. You or your legal counsel or agent or agent representative may contact the lawyer appointed to represent the Professional Conduct Committee, namely:


